# RESOLUTION TOWN OF RESACA, GEORGIA

WHEREAS, Tao Quoc Nguyen of Chatsworth, Georgia has filed application number Z21-13 with Gordon County for a conditional use permit for twenty-for industrial chicken houses to be located on Evergreen Road in the unincorporated portion of Gordon County, Georgia, and,

WHEREAS, it is reasonably anticipated that twenty-four industrial chicken houses will generate approximately five crops of chickens per year, amounting to millions of birds, requiring numerous truck trips to support that operation, and,

WHEREAS, the natural and shortest truck route between Evergreen Road and destinations north or west of Gordon County will be through the Town of Resaca to the I-75 interchange with Highway 136 (see exhibit A); and,

WHEREAS, the Town of Resaca already experiences significant traffic challenges at the intersection of the north-south Chattanooga-to-Atlanta CSX rail-line, Highway 136 and U.S. 41; and,

WHEREAS, that intersection does not have a traffic signal other than a 2-way stop sign; and,

WHEREAS, Highway 136 is regularly blocked by stopped CSX trains, and,

WHEREAS, there is no other convenient route around this intersection in the event of an emergency, and,

WHEREAS, the Mayor and Town Council reasonably expect that the addition of the numerous tractor-trailers required to serve Mr. Nguyen's proposed industrial chicken house development will substantially impair the flow of traffic at this intersection; and,

WHEREAS, this intersection is in the heart of the Town of Resaca, such that its impairment will negatively impact the quality of life of many of the residents of Resaca;

THEREFORE, IT IS HEREBY RESOLVED by the Mayor and Town Council that the honorable members of the Gordon County Planning Commission are urged to recommend denial of this conditional use permit; and the honorable members of the Gordon County Board of Commissioners are requested to deny this conditional use permit. In making this resolution, the Mayor and Town Council are not objecting to growth, development, or agricultural operations in Gordon County, however, the proposed use is of an intensity that is too great, and will have a negative and detrimental impact on the citizens of the Town of Resaca.

So resolved by the Town Council this 3th day of June, 2021.


